Computer Use Consent

LCBI is preparing students to compete in the global economy. Computer use, computer networks and Internet services can enhance the educational program and help students develop the knowledge and skills needed to be successful.

Computer Networks

LCBI has an electronic network which allows students to access the Internet. The Internet is an electronic highway connecting computer users, computer networks and information around the world. Students using the Internet may have access to electronic mail (e-mail) and public domain software, discussion groups, university libraries, information from research institutions, and more.

The Internet opens a world of valuable information to students. However, some information on the Internet may be considered inappropriate for young people. LCBI has no control over information on the Internet and is limited in its ability to control access by students to inappropriate information.

Parents/guardians are encouraged to discuss their expectations for appropriate activities on the Internet with their student(s). Using computer services, it may be possible for a student to purchase goods and services for which the parent may be liable. LCBI is not responsible or liable for a student's use of or access to the Internet that is in violation of the school's rules, nor for lack of access to the Internet, nor for the accuracy of information received.

Except as required, the use of school computers is a privilege that may be revoked at any time. It is important to understand that work on school computers is not private or protected. Use of school computers, computer networks, and the Internet does not create any expectation of privacy. The school reserves the right to search any information sent, received, or stored in any format. The school is not liable for damage to or loss of students' work maintained in computer files. Parents have the right to examine their student's file if the information is accessible.

Except as required, the use of school computers and access to the Internet is a privilege. Students who do not follow the computer use rules may be disciplined, and may lose computer privileges.
